## Israel bombards Gaza, 123 killed in 24 hours



Hostages' families have mounted pressure on Israel's PM Benjamin Netanyahu to prioritise their release

#### **Agencies** CAIRO/JERUSALEM

Israel's military pounded Gaza City on Wednesday prior to a planned takeover, with another 123 people killed in 24 hours, according to the Gaza health ministry, while militant group Hamas held further talks with Egyptian mediators. The 24-hour death toll was the worst in a week and added to the massive fatalities from the nearly two-year war. Israeli PM Benjamin Netanyahu reiterated an idea, also enthusiastically floated by US President Donald Trump, that Palestinians should simply leave. "They're not being pushed out, they'll be allowed to exit," he told Israeli television channel 'i24NEWS'.

"All those who are concerned for the Palestinians and say they want to help the Palestinians should open their gates and stop lecturing us."

Hamas chief negotiator Khalil Al-Hayya's meetings with Egyptian officials in Cairo were to focus on stopping the war, delivering aid and "ending the suffering of our people in Gaza," Hamas official Taher al-Nono said. Egyptian security sources said the talks would also discuss the possibility of a comprehensive ceasefire that would see Hamas relinquish governance in Gaza and concede its weapons. A Hamas official said the group was open to all ideas if Israel ends the war and pulls out. However, "Laying down arms before the occupation is dismissed, is impossible," said the official.

New Zealand's PM Christopher Luxon said on Wednesday that his Israeli counterpart Benjamin Netanyahu had "lost the plot" as the country weighs whether to recognise a Palestinian state. "What we are seeing overnight, the attack on Gaza City, is utterly, utterly unac-

His remarks came a day after Greens MP Chloe Swarbrick was removed from parliament's debating chamber on Tuesday after she re-

fused to apologise for a comment insinuating government leaders were spineless for not supporting a bill to "sanction Israel for its war crimes." She was ordered to leave the chamber again on Wednesday for refusal to apologise.

#### Mamdani holds lead in mayoral race

The democratic primary,

Zohran Mamdani has emerged as the frontrunner in New York City's mayoral race, leading by a significant margin in a crowded 5person contest, The Hill reported. A new Siena College poll shoed Mamdani has 44% support among registered voters in New York, placing him 19 points ahead of former New York Governor Andrew Cuomo, who comes in second with 25% Republican nominee Curtis Sliwa trails with 12%, while current Mayor Eric Adams garners just 7% support. Cuomo, who lost the Democratic primary to Mamdani in June, and Adams, who skipped the primary altogether, are both still registered Democrats but are running independent campaigns in the general election.

#### **US** warships in disputed S China Sea

The US deployed 2 warships on Wednesday in a disputed South China Sea shoal, where two Chinese navy and coast guard ships collided two days ago while trying to drive away a smaller Philippine ship in a high-seas accident captured on video, alarming several Western and Asian countries. Both China and the Philippines claim Scarborough Shoal and other outcroppings in the South China Sea. Vietnam. Malaysia, Brunei and Taiwan also lay overlapping claims in the contested waters.

#### India to get addl 200 MW from Nepal

Nepal will export nearly 200 MW electricity to India in addition to the existing 940 MW, officials said, a development that will earn little over NRs 80 billion for the Himalayan nation. This is part of the long-term agreement that Nepal signed for the export of 10,000 MW power to India over the next 10 years, most of it during the rainy season between June to November. "The Central Electricity Authority of India on Tuesday approved the import of additional 199.70 MW electricity from Nepal to Haryana," Nepal Electricity Authority spokesperson Rajan Dhakal said.
